## Overview

To register your cat or dog for the first time, please make sure:

- » Your pet has not previously been registered in Casey. If you have previously registered your pet, you can renew the registration. If your pet was registered at another Council, or to another owner, you may be able to transfer the registration.
- » You have complied with the Local Law regarding excess animal ownership.
- » You are over 18 years old.
