1. **Request that the Minister for Planning appoint a Panel under Section 153 of the *Planning and Environment Act 1987* (the Act) to consider the written submissions received on Amendment C300case, subject to the following amendment being made to the publicly exhibited amendment and before a request is made to the Minister:**
  - (a) **In Schedule 26 to Clause 43.04 Development Plan Overlay, Clause 3.0 Conditions and requirements for permits, replace the existing section “Environmental Audit” with the following section:**

***Environmental Audit***

**An environmental auditor must conduct an environmental audit under Part 8.3, Division 3 of the *Environmental Protection Act 2017* for all relevant potential risks to human health or the environment from contaminated land, waste, pollution or any activity associated with the former Stevensons Road and Casey Landfills and the former Casey Landfill Waste Transfer Station.**

---

**Prior to the commencement of works or the certification of a plan of subdivision under the *Subdivision Act 1988*, whichever occurs first, the permit holder must provide to the Responsible Authority:**

- (i) An environmental audit statement under Part 8.3, Division 3 of the *Environmental Protection Act 2017* must be issued stating that the land is suitable for a sensitive use; or**
- (ii) An environmental audit statement under Part 8.3, Division 3 of the *Environmental Protection Act 2017* must be issued stating that the land is suitable for a sensitive use if the recommendations made in the statement are complied with; and**
- (iii) All the recommendations of the environmental audit statement must be complied with to the satisfaction of the Responsible Authority. Written confirmation of compliance must be provided by a suitably qualified environmental consultant or other suitable person acceptable to the Responsible Authority. Compliance sign-off must be in accordance with any requirements in the environmental audit statement recommendations regarding verification of works.**

- (b) In Schedule 26 to Clause 43.04 Development Plan Overlay, Clause 4.0 Requirements for development plan, Urban structure plan, insert a new bullet point requirement 10:**

**General landscaping principles, including demonstration of a minimum 30 per cent tree canopy cover within the public realm and in open spaces (excluding areas dedicated to biodiversity or native vegetation conservation).**

- 2. Refer all written submissions on Amendment C300case to the Panel, under Sections 23(1)(b) and 23(2) of the Act; and**
- 3. Notify all submitters on Amendment C300case of Council's decision.**

*The new upgrades to the playground at Kendall Dr Reserve are much welcomed, though there is still a sizeable area of empty land there that is not being utilised. Does Council have any plans for this land? Could it be used to plant more trees and other plants as a sort of tiny forest or even a mini botanical garden?*

*Thanks Patrick for your question, and it's great to hear the positive feedback about the playground. Council does not currently have plans for the land to the north of the playground. Previous feedback that we have conducted has indicated that the community value this area for informal sporting activities, and maintaining clear sightlines to the playspace is important. We will take on board your suggestion for increased planting in the area in accordance with Casey's Greening Casey Strategy.*

**Question 2** Lighting along Ernst Wanke Rd

*Could Council explore the possibility of adding street lighting along Ernst Wanke Rd between Jacksons Rd and Maramba Dr? The rest of Ernst Wanke Rd largely has street lights, though this section does not and so it is quite dark along there at night. I notice many people walk along this stretch for exercise and often have to use torches in order to see.*

*Ernst Wanke Road is a busy arterial road with very few properties directly fronting it. Lighting is already provided at all side streets and roundabouts along this section, which is the standard approach used by both Council and the State Government for roads of this type. At this stage, there are no plans to add further street lighting along this stretch of Ernst Wanke Road.*

**Question 3** Berwick Springs Lake Renaming to Guru Nanak

*Temporary signage placed at Berwick Springs Lake on 9/11/24 stated, "permanent signage will be developed in consultation with Casey, Melb Water and Sikh communities "Residents were not noted to be included in the process.*

*Can council update. Have council been approached or involved in any discussions about permanent signage or monuments? If so, what will it look like? Where will it be placed? When will it be installed? Are Casey residents paying if it gets vandalised or damaged?*

The response was prepared by Manager Growth and Investment and answered by Director City Planning and Infrastructure

*Council has previously advocated for the State to consult with the community on the design and location of any new signage for the gazetted name Guru Nanak Lake. Officers most recently wrote to the Department of Premier and Cabinet on 23 December 2024 to request that this consultation occur. Council has not yet received a response from the State. Any signage installed to name a feature on land owned by Melbourne Water will be the responsibility of Melbourne Water to maintain.*

**Question 4** Guru Nanak signage at Berwick Springs Lake

**Submitter:** Michael Ball

*If Casey have not been consulted on the signage or installation process yet, can the Berwick Springs Community Association request.*

*That Casey council will advocate to the State Govt and Melb Water in these discussions, that unlike the Renaming process where there was no community consultation that the local community and residents will be consulted on options, designs and provided the opportunity to object before any installation occurs. Can the Association be updated on any developments.*

*Before Covid the Saturday before the Moto GP on Phillip Island Cranbourne with the support of the City of Casey hosted a community Event. This event involved the wave of large numbers of Motor Bikes heading to the Island in convoy. This use to take place in the main street of Cranbourne. This year in October will be the final GP on the Island i was wondering if the council might consider reviving this Event for one last time?*

Can the City of Casey confirm whether it is considering a similar change to the current weekly rubbish collection service for residents, and if so, what consultation will occur?*

*Our records indicate that in 2016 Council transferred \$2.176 million collected under the Developer Contributions Plan to the State Department of Economic Development, Jobs, Transport and Resources who are responsible for delivering the railway electrification project. The extension of the expiry date of the DCP will allow Council to continue to collect development contributions to fund the railway electrification project.*
