OVERVIEW

To register your cat or dog for the first time, please make sure:

- Your pet has not previously been registered in Casey. If you have previously registered your pet, you can renew the registration. If your pet was registered at another Council, or to another owner, you may be able to transfer the registration.
- You have complied with the Local Law regarding excess animal ownership.
- You are over 18 years old.

- Service Dogs (Guide or Customs Dogs) are exempt from fees.
- Restricted breeds are: American Pit Bull Terrier, Pit Bull Terrier, Japanese Tosa, Dogo Argentino, Fila Brasileiro, and Perro De Presa Canario (Presa Canario).

**Included in the above fees is a Victorian Government registration fee of \$4.10 for each animal.*
