

Overview

The TAC L2P - Learner Driver Mentor Program helps learner drivers aged 16 to 23 years old, who do not have access to a supervising driver or vehicle, gain the driving experience required to apply for a probationary licence.

The TAC L2P program is FREE for ELIGIBLE young people who live in the City of Casey. Learner drivers are matched with a fully licensed volunteer mentor and have access to a sponsored vehicle, which they can use to get supervised driving experience and work towards their 120 driving hours.

Please note there is currently a 12 month wait list for eligible applicants.
