

OVERVIEW

Clause 11 of the Casey Community Local Law 2025 states that a person who owns or occupies land must not, except with a permit, keep or allow to be kept any more of each of the type of animals, stated in the table below or keep or allow to be kept any livestock on private land less than 4,000sqm in area.

Animal	Less than 1000sqm	1000sqm – 4000sqm	Greater than 4000sqm
Dog	2	2	4
Cat	2	2	4
Poultry	5	7	20
Rabbit	5	5	10
Large Bird	5	7	20
Small Bird	10	20	30
Pigeons	5	10	20
Rooster	0	0	1





Structures to enclose/house animals must be:

- at least 6 metres (m) from the front of the property; and
- at least 1.2m from any boundary of the land; and
- at least 3m from any dwelling on your neighbours' property (adjoining land); and
- not less than 3m from the nearest dwelling on your land (except for a dog kennel, cat enclosure or bird aviary used to house small birds)

➤ **Using the symbols below, show the location of all:**

- houses/dwellings and garages on your property; and
- animal enclosures on your property (aviaries, kennels, catteries, fences, stables, other enclosure); and
- livestock water and feed troughs on your property
